Establishment Date

31-7-1988

(1) NAME OF TRUST

- Name of this trust is given "JAMIAH ULUMUL KURRANE" JAMBUSAR.

(2) JURISDICTION OF TRUST

:- It is limited within the population of muslim villages of the Gujarat State. If it is necessary, jurisdiction shall be extended.

(3) ADMINISTRATIVE YEAR

:- It is start from Islamic year of month Mohoram to year and month ending of Jilhaz.

(4) PURPOSE OF TRUST

(1)It taught and trained of Arbi & Dini Ulum alias Kurrane Majid & Tafsir and Hadis & Fikah with Akaed & Kalam and religious educations, and

TRUE COPYArts And to trained essential & necessary in other languages.

Maulana Madni Memorial High School Jambusar,

- (2) For the purpose of protection of Islamic religion and spread necessary materials published, and to give training & encourage for streem of Tablig through Vaez & Lactures.
- (3) For the purpose of Islamic Training and Tahzib ,Arbi Madresas(Schools) & Boardings are established.
- (4) For the educational Spreadation in Muslim minority community active affort shall be taken on hand. And if possible necessity Secondary school, and Higher Secondary school and like I.T.I Technical & Occupational training institution established.
- (5) For the purpose of lively hood equipment of muslims, prepared for handicrafts, artision industries, to train themself.
- (5) MEMBERSHIP :- Any brother of Muslim may be member of this AHALE SUNNATVAL JAMAAT AKLDAWALA (Holder of Devbandi Streem)

(6) TRUST COMMITTEE:-

- (1) Establishment trustees are permanent trusties of this trust.
- (2) Minimum of seven members, and Maximum of Eleven members shall be of the trust.
- (3) Trust Committee shall be called and govern by The "Darul Karran", Who is fully Administer of "Darul Karran"
- (4) Any member of general meeting shall be appointed on empty seat(s) of the trust, by reason of trust committee's resignation or death of the trustee by the continuous trustee.
- (6) Minimum three members are AALIM of total trust committee.
- (7) Trust Committee may appoint if necessity subcommittee.
- (8) One of the ALIM shall be appointed as managing trustee from the trust committee managing trustee

 MURENO. should be AALIM. [The appointment of AAILM shall

 be posted as managing trustee only from the Juambusar,

 Taluka.]
 - (9) Membership of trustee committee shall be ended as shown in below incidents:a. Member's Death

- b. Any Member remain absent, without showing reasons, absent in constant three meetings.
- c. Any member of the trust shall be removed from the trust who behaved against interest of trust or involve in such activities, and found quilty.

Under section 6 (4) above, empty seats of the trustee shell be filed as shown above (A) to (C)

- (10) Minimum Two Meetings of the trust committee shall be called within one year. Special Meetings shall be called, by the managing trustee, if required.
- (11) Agenda shall be reach each members before seven days of general required meeting in special circumstanced managing trustee may called meeting before 24 trust members knowledge of the notice.
- (12) In meeting of trust committee corum shall be 2/3 of the total members adjournment of meeting due to corum, it will be start twenty four hours. No corum is required in this meeting trust committee shall be appointed time to time by the general board.

(7) RIGHTS AND DUTIES OF TRUST COMMITTEE:-



- Basic principles and aims of "DARUL KURRAN" is to protect. For administration of Darul Kurran laws & rules should be fraimed.
- 2. Assistants & other paid salary employers of Darul Kurran are appointed, and they discharged, Promotions, Degradetion & their salaries, designations & duties fraimed and make changes of their duties & designation.
- 3. Leave granted of salary servants of the trust.
- 4. Take on discussions of sub committee's report. And such sub-committee's resolutions may be granted or rejected, and to hear an appeal of such resolutions of sub-committee's report accept or reject, and give final decision.
- 5. If required personal rights & duties shall be transferred to special officer or any special member, or designated person or transfer to sub-committee.
- 6. Give protection to properties and balance of Darul Kurran and make principles of Income expenditures.
- All properties & Vakafs shall be taken in to possession, give protection & income shall be recovered of Darul Kurran.



- 8. At the end of year account shall be audited and section such account and give section of annual budget of Darul Kurran.
- 9. As and above essential rights for the progress & strengthen of Darul Kurran such rights shall be enjoyed.

(8) RIGHTS DUTIES OF MANAGING TRUSTEE:-

- (1) Seatings of majlees sure & trust committee be called & handle its President ship.
- (2) For preservation discipline decorum should be maintain in each & every trust meetings, unlawful discussion or hefezard talk shall not be discussed by any member.

Disobedience in trust meeting, person(s) shall be dismissed from meeting.

- (3) If in trust scating any other stream person appear, then that scating shall be cancelled or adjourned by rights.
- (4) All administration and accommodation of Darul Kurran shall be watch and on salary employer.
- (5) If in any case equal votes counted then extra vote shall be delivered by right in trust seating.

- (6) Trust's all corruspondance shall be handle, and annul report shall be prepared.
- (7) As trust committee direct, accept the trust amount and spent for development of Dural Kurran.
- (8) Maximum Rs. 3000/- balance is kept on hand.
- (9) At a time, for one work Rs. 2000/- shall be spent and for more expenditure trust committee's consent is required.
- (10) Gradually Donations funds shall be collected for income of the trust and planed for increase income of the trust.
- (11) Trust committee shall appoint managing trustee.
- (12) Managing trustee shall be administer & control over sub-committee and duties perform, rights enjoy designated authority.

(9) INCOME OF TRUST :-

- (1) Funds collection
- (2) Donations fund collection
- (3) Income from property quilt
- (4) Aids from Government if required for the subcommittee

(12) OFFICE: Dural Kurran's Office shall be in JAMBUSAR TOWN.

(13) AMENDMENT AND ALTERATION IN RULES:-

Trust Committee has rights to amend and or alter in rales of "Dural Kurran" For alteration of and amendment in the interest of trust permission Cherity Commissioner shall be taken. Trust committee shall be passed any alteration or amendment by mejority in their meeting.

(13)Liturary meaning of "Dural Ulum" is "Jamiyah te Ulumul Kurran" is identified in Constitution.






POSED TECHNICAL BUILDING PLAN JAMIAH INDUSTRIAL TRAINING CENTRE, BUSAR,
